ORDER

Provisional Affiliation was granted to start a new Architecture College viz. Nehru College of Architecture, Lakkidi, Mangalam, Palakkad under Nehru College of Educational and Charitable Trust, Pampady, Thrissur, with B.Arch programme (40 seats) during the academic year 2015-16 vide U.O read as 1st above, in the light of the Interim Orders of the Hon'ble High Court of Kerala in WP(C) No. 29326 of 2015 and WP(C) No. 29356 of 2015 dated 28.09.2015, subject to the disposal of the Writ Petition .

- 2. The Principal has not submitted the renewal NOC from Government as insisted vide U.O read as 2nd above, which is mandatory for granting Continuation of Provisional Affiliation.
- 3. Continuation of Provisional Affiliation for B.Arch programme with an intake of 40 students was granted vide U.O read as 4 $^{\rm th}$ above, for the year 2020-21 & 2021-22 without insisting renewal NOC from Government for the years 2020-21 & 2021-22 on the basis of interim Order of Hon'ble High Court vide paper read as $3^{\rm rd}$ above in the Writ Petition (C) No.11715/2020(L).
- 4. The Principal, Nehru College of Architecture, Lakkidi, Mangalam, Palakkad has applied for Continuation of Provisional Affiliation to B.Arch programme for the academic year 2022-23 vide paper read as 5th above. An amount of Rs 3,52,800/- (Rupees Three Lakh Fifty Two Thousand Eight Hundred only) has been remitted towards Administration and Affiliation fee vide chalan No.212605714 dated 21.12.2021.
- 5. The College has submitted the Extension of Approval Order from the Council of Architecture for the academic year 2022-23 with an intake of 40 seats, vide paper read as 6th above.
- 6. Considering the above, the Vice Chancellor has accorded sanction on 31.08.2022, to grant Continuation of Provisional Affiliation to B.Arch programme with 40 seats at Nehru College of Architecture, Lakkidi, Mangalam, Palakkad, for the academic year 2022-23, on conditional basis subject to submission of renewal of NOC from Govt. for the academic year 2022-23.
- 7. Continuation of Provisional Affiliation to B.Arch programme with an intake of 40 seats is therefore, granted at Nehru College of Architecture, Lakkidi, Mangalam, Palakkad for the academic year 2022-23, subject to the submission of renewal of NOC from Govt. for the academic year 2022-23.
- 8. Affiliation granted is strictly provisional and only for the academic year 2022-23. The continuation of provisional

affiliation for the ensuing years should be obtained after applying for the same along with required fee and extension of approval order from the apex body concerned.

- 9. Selection and admission shall be made only on the basis of the Rules and Regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- 10. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.
- 11. The conduct of University Examinations of any sort, including that of SDE examinations, is compulsory and binding on all colleges affiliated to the University of Calicut.
- 12. In the light of the direction of the Hon'ble Supreme Court of India in WP(C)656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging appropriate action including withdrawal of the affiliation of the college will be initiated.
