

- Institution must recruit 2 Assistant Professor (as per shortfall based on confirmed faculty in application) before the commencement of academic session.
- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms should be appointed/ maintained by the institution at all times.

The institution shall initiate necessary remedial actions, if any, based on the observations of the Executive Committee and send its compliance/observations on the same for further consideration. 
